

Parents and Guardians are hereby informed that, in compliance with the order passed by the Hon'ble High Court of Calcutta in W.P. 5890 of 2020, dated 13th October 2020, the management of the Calcutta Girls High School, has taken the following decisions in regard to the school fees :

1. The school Management, in compliance with the above stated judgement, with effect from April 2020, superseding all previous decisions taken in regard to the concession of school fees, has decided to offer 20% waiver on school fees across the board. Please find enclosed herewith the revised fee structure as Annexure - I.
2. However, as per clause vii of Para 61 of the said order "Parents and guardians of students are requested not to avail of the reduction in school fees, if their financial situation does not merit the reduction."

Parents, therefore, may opt to pay the full fees in case there is no financial constraint through the online portal or in the bank. In such case, parents are requested to send their consent to the accounts office at cghsaccounts@yahoo.co.in

3. All due fees till November 2020 should be paid by 30th November 2020 (as per clause xviii of Para 61 of the said order).
4. Parents availing the 20% reduction are to pay the fees as per Annexure I. Parents are to collect the payment slip from the School Office and deposit the same in cash at the Axis Bank Ltd., 69, Ganesh Chandra Avenue, Kolkata - 700013.
5. Parents who have already paid the full school fees and wishing to avail the 20% waiver are requested to meet the accounts office staff for suitable adjustments to be made over the remaining months of the financial year. Parents are to bring all relevant payment receipt on any working day from 16th November 2020, between 11:00 a.m. to 2:00 p.m.
6. This Fee structure will be applicable till the issuance of further notice.
